LEASE AGREEMENT TERMS:

- 1. The instrument you are leasing is the sole property of JOHN KEAL MUSIC CO. You may not sell it or move it to another state. You must notify the company if you change address or phone.
- 2. You will receive a coupon slip with the monthly/annual payment and due date. All lease payments are due in advance. There are no refunds on lease monies paid. Past due payments and late charges do not apply toward purchase of any instrument. A late charge of \$5.00 + tax per month is assessed on late payments. A payment is considered late if not received within 25 days of due date. If 60 days overdue this agreement may be cancelled and the unpaid balance shall become due immediately. If an account is turned over to a collection agency you will be responsible for collection costs.
- 3. The company may repossess an instrument if there is any charge that is 60 days in arrears. Repossession terminates this agreement but does not relieve you of charges incurred before or after repossession (including legal fees).
- 4. In the event that the instrument is lost or damaged beyond repair, you will be required to pay 70% of the current retail value of the instrument, regardless of the age or condition. The company shall be the sole judge in all cases.
- 5. The company reserves the right to refuse to lease an instrument based on the results of a credit investigation.
- 6. All repairs must be made by John Keal Music Company. The company has the right to pick up the instrument at school at six month intervals to provide adjustments. Permission of the renter is not required for this service.
- 7. The lessee retains the right to terminate this agreement at any time by returning the instrument to the company. You are responsible for an instrument until it is returned to our place of business. Phone John Keal Music Co, to return the instrument at 518-482-4405.
- 8. If the rental instrument is in need of repair, we will switch it for another instrument of the same size and value. The company will repair or replace the instrument if it is not functioning properly as a result of normal usage. The company does not provide replacement strings, rosin, or bows. The company will provide this service as long as your monthly lease payments are up to date. If the account falls behind, you will be responsible for the overdue payments and the cost of the repairs. Any repair needed as a result of malicious damage caused by the student will be billed to the renter. Malicious damage is not covered and will automatically terminate this agreement.

NOTICE TO CONSUMERS:

You may cancel this agreement any time prior to midnight of the third business day after you receive the instrument. A copy of this agreement will be mailed to the address you have provided. Do not sign this agreement before you read it. Keep your copy of this agreement to protect your legal rights.
